### INSTRUCTION TO BIDDER

#### 1. Submission of Bids: -

The bidder shall submit the bid in Electronic Mode only i.e [www.tenderwizard.com/OPTCL](http://www.tenderwizard.com/OPTCL). The OPTCL reserves the right to reject any bid, which is not submitted according to the instruction, stipulated above. The participants to the tender should be registered under IT Act / GST Act.

1. For all the users it is mandatory to procure the Digital Signatures.

**3. Supply of materials:-**

The supply of materials required for day-to-day maintenance should be good quality and reputed make. No extra amount will be paid towards transportation handling, storage and overhead expenses.

a) The price should be firm and breakup for each item should be furnished along with the bid.

b) EPF & ESI: It is your responsibility to deposit EPF and ESI of personnel engaged for the work by you.
