The sealed tender of each vehicle should be submitted separately on or before 25.03.2021, 01.00PM in the office of the GM(Transport), Hqrs, OPTCL, Janpath, Bhubaneswar-22, super-scribing the vehicle Registration Number and the Model on top of the envelope, which shall be opened on the same day at 04.00 PM in the presence of Tenderers or their authorised representatives. The above mentioned vehicle can be inspected by the tenderers in the Hqrs office, OPTCL premises during office hours, with intimation to the GM (Transport), OPTCL.

The intending purchasers are requested to pay Rs2,100/-(Rupees two thousand one hundred) only for each vehicle as earnest money in shape of **Bank Draft** drawn in favour of Drawing & Disbursing Officer,OPTCL Hqrs.office, BBSR. The earnest money will be refunded to the unsuccessful tenderers. The highest tenderer will have to deposit at least 25% of the offered amount within seven days with the D.D.O., Hqrs. Office,OPTCL after the tender is accepted by the Competent Authority. The balance amount if any should be deposited within twelve days. If the successful tenderer fails to deposit the full amount within the stipulated period, the earnest money so deposited shall be forfeited.

In case the vehicle(s) is/are not lifted within 45 days from the date of finalisation of tender, the ground rent, at the rate of 1% of the tendered amount for each day of delay will be charged. When the ground rent for the vehicle so charged exceeds the price deposited, the tenderer shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become the absolute property of OPTCL, free from encumbrance and to be disposed of by fresh tender.
