2. The Bid will be opened on **24.09.2024** at **11.30 A.M** in the office of the undersigned in the presence of the empaneled bidders or their authorised agent who wish to attend. If the office happens to be closed on the last date of receipt and opening the bids will receive and opening on the next working day at the same time and venue.

3. Bid must be delivered in the tender box having identification No.**EE-CWD-I-01/24-25**

4. Bid document can be purchased from the office of the undersigned against a nonrefundable fee towards cost of the documents in Demand Draft issued from any Scheduled Bank payable at Bhubaneswar in favor of Superintending Engineer (Civil) Civil Works Circle –OPTCL-Bhubaneswar.

5. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs.500.00 on shape of DD as mentioned above, over & above the cost of Tender documents. The Executive Engineer (civil), Civil Works Division NO-I, OPTCL, BBSR will not be held responsible for the postal delay if any in the delivery of the documents or non-receipt of the same in time.

6. All other facilities as per OPTCL norms will be available to the eligible Bidders.

7. Bids must be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost put to tender specified for the work in shape of Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account pledged in favour of Superintending Engineer (Civil) Civil Works Circle –OPTCL-Bhubaneswar

8. The Authority reserves the right to reject the above Tender without assigning any reason thereof.

9. The tender amount is excluding of GST, while passing the bills, GST to be included at the applicable rates. The contractors have to deposit the GST amount which are paid by OPTCL along with the contractor bill to the respective Govt. Department within due date and time.

10. The amount put to tender is inclusive of 1% cess which will be adjusted during payment of bills. The contractor shall have to produce labour licence within seven days of agreement if required by the undersigned.

11. Bidders are requested to quote the rate at par to schedule of rate or below the scheduled of rate at a maximum of @ 14.99%.

12. **Additional performance security** shall be obtained from the bidder **before drawl of agreement**, He has to submit the Additional Performance Security for the amount as detailed below in Shape of Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of Superintending Engineer (Civil) Civil Works Circle –OPTCL-Bhubaneswar **at the time of agreement**.

14. ISD (Initial Security Deposit) value is 1% of the bid amount and is to be deposited by the contractor before drawl / signing of the agreement in the shape Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of Superintending Engineer (Civil) Civil Works Circle –OPTCL-Bhubaneswar at the time of agreement

15. The Successful contractor shall have to claim for refund of EMD, within a period of one year and shall have to claim for refund of Security deposits within a period of three years from the date of completion of contract, otherwise it will be forfeited.

16. EPF and ESI certificate along with last 03 month (i.e, June 2024 to August 2024) updated challan is mandatory for qualification.

17. The bidders are to submit an affidavit certifying that the documents & information furnished by them are genuine.

18. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work shall be liable for rejection of all such tender paper of the concerned bidder. **A bidder cannot be purchaser of tender paper of another bidder.**

Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference and for availing the facilities. The Security Deposit(Earnest Money, Initial Security and Performance Security) at half the usual rate may be deposited/ realised by/ from the Scheduled Caste or Scheduled Tribe Contractors coming under the categories upto "B" Class only as against the prescribed percentage.

19. Before tendering, the bidder may visit the sites and satisfy himself, as no claim what-so-ever shall be entertained for any alleged ignorance, after the tender is opened.

9. The bidders shall furnish the self-attested copies of Contract License, PAN, GSTIN and other documents as mentioned in clause no 26 of the DTCN. They may go through the outright rejection criteria as mentioned in DTCN.
