

The collection fee & Paper cost is nonrefundable. Additional amount of Rs.100/- (One Hundred only) may be paid extra for postal delivery of the tender specification. The undersigned shall not be held responsible for any postal delay.

The Tender shall be received Up to 02.30 PM on dated 24.02.2026 & will be opened at 03.30 PM of same day in the office of the undersigned in the presence of the Bidders (or) their Authorized Representatives present if any. If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D including GST i.e. **Rs. 5,000/-** should be deposited in shape of Demand Draft / Cash in favour of **E.H.T (O&M) Circle, OPTCL, Burla** payable at Burla, Odisha along with Self Attested Copy of **Manufacturers /Authorized Dealership Certificates, PAN and GST Registration Certificate** failing which the tender will be liable for rejection.
