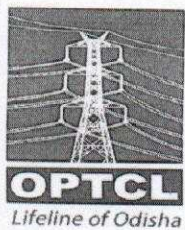

If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D including GST i.e. **Rs. 5,000/-** should be deposited in shape of Demand Draft / Cash in favour of **E.H.T (O&M) Circle, OPTCL, Burla** payable at Burla, Odisha along with Self Attested Copy of **Manufacturers /Authorized Dealership Certificates, PAN and GST Registration Certificate** failing which the tender will be liable for rejection.


