For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the http://tenderodisha.gov.in by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).
- 2. The bidders may submit bid for the works as per the following table :-

Post Office Savings Bank Account /Post Office Time Deposit Account pledged in favour of EE,CWD-I, OPTCL, Bhubaneswar will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

- 4. The Bid documents will be available in the http://tendersorissa.gov.in from 11.00 Hours of 31.08.2019 to 18.09.2019 up to 17.00 Hours
- 5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-III or Class-III.
- 6. Bids shall be received only "online" on or before 17.00 Hours of 18.09.2019
- 7. The Cover-I (Techno-Commercial Document) of the Bids received "on line" shall be opened at 10.30 Hours on 23.09.2019 in the office of the Superintending Engineer (Civil), Civil Works OPTCL, Circle. Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of Cover-II (BOQ) will be communicated in due course of time to the qualified bidders of Cover-I.
- 8. The bidders shall furnish the self-attested copies of Contract License, PAN,GSTIN and other documents as mentioned in the DTCN. They may go through the outright rejection criteria as mentioned in the DTCN.
- 9. Additional performance security shall be obtained from the bidder before drawl of agreement. he has to submit when the bid amount is less than the estimate cost put to tender in such an even the bidder who have quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e. estimate cost put to tender minus the quoted amount as Additional Performance Security in Shape of Demand Draft/NSC/KVP/Term Deposit Receipt pledge in favour of **EE,CWD-I, OPTCL, Bhubaneswar** in the sealed envelope along with the Tender Cost & EMD. Failing which the bid will be rejected.
- 10. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.

The packet super scribing the name of the work and containing cost of bid document & EMD/Bid Security in original and other documents may be submitted in the office of the undersigned after bid closing date 18.09.2019 and on or before 17.00 Hours on dated 21.09.2019 during office hours on working days .Submission of the same by courier/postal will not be considered.
