- 1.0 This invitation for bids follows the e-procurement notice (Invitation for Bids) for the subject package published on **Dt. 05.02.2026** on **OPTCL website** and e- procurement portal of OPTCL.
- 2.0 “Odisha Power Transmission Corporation Limited (OPTCL)”, A wholly owned Undertaking of Government of Odisha, incorporated under the Companies Act, 1956, having its Registered Office at Janpath, Bhubaneswar – 751022 (hereinafter referred to as Owner’) has decided to set up, as an Owner & intends to enter into a contract with the contractor to be named in the letter of award (LOA) for the following the projects:

“Name of the project (Packages): (1) –

**Design, Engineering, Supply, Erection, Installation, Testing & Commissioning 400 KV DC LILO Line from existing 400 KV Kuchei-Pandiabil & Kuchei-N.Duburi DC line to proposed 400/220KV GIS, at Ramakrushnapur in Bhadrak District (Approx Line Length = 4.642 KM) on “EPC/Turnkey CONTRACT BASIS”.**

The procurement activities in respect of the aforesaid Project above shall be carried out by the OPTCL and it intends to use domestic/any other means funding for eligible payments under the contract for the package(s) as mentioned above. For the purpose of all procurement activities, the Owner shall also be referred to as ‘Employer’.

OPTCL, therefore, invites bids from eligible bidders for the subject package on Domestic Competitive Bidding basis under secured e-procurement procedure **on Percentage rate tendering basis**. This Invitation for Bids extended through media, website or written communication or by any other means, shall not be construed to mean that the prospective bidders to whom the Invitation for Bids has been extended is deemed to be an eligible bidder. The eligibility of the bidders shall be

determined as per the provisions of Bidding Documents.

- 3.0 The detailed scope of work is given in the Technical Specification (**Volume-II**) of the Bidding Documents.
- 3.1 The completion period for the subject Package shall be the period as specified in **ITB Sub-Clause 24.1(c)**.
- 3.2 Bidding will be conducted through the Domestic Competitive Bidding procedures as per the provisions of **ITB/BDS** and the contract shall be executed as per the provisions of the Contract conditions. The respective rights of the Employer and the **Contractor** shall be governed by the Bidding Documents/Contract signed between the Employer and the Contractor for the package. The provisions of the Bidding Documents shall always prevail in case of contradiction.

4.0 The detailed Qualifying Requirements (QR) are given in the Bidding Document.

5.0 Important Instruction for participation in subject e-Tendering:

- a) Bidders are requested to regularly visit Official website / e-Tender Portal of OPTCL only for amendment/errata/corrigendum (if any) and any other information regarding these tenders and to visit the proposed Works Sites and get familiarized fully with the site conditions & requirements before proceeding for submission of bids. In case Hard copy part of the bid is not received by the Employer till the deadline for submission of the same prescribed by the Employer, but the bidder has uploaded the soft copy part of the bid, the soft copy part of the first envelope bid uploaded on the portal shall be opened. Such bids will be rejected during preliminary examination.
