For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the http://tendersodisha.gov.in by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).
- 2. The bidders may submit bid for the works as per the following table :-

- 4. Bids must be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1

% of the estimated cost put to tender specified for the work in shape of Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account pledged in favour of SE, CWC, OPTCL BBSR and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

- 4. The Bid documents will be available in the http://tendersodisha.gov.in from 15.30 Hours of 08.08.2025 to 29.08.2025 up to 17.00 Hours.
- 5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
- 6. Bids shall be received only "online" on or before 17.00 Hours of 29.08.2025.
- 7. The Cover-I (Techno-Commercial Document) of the Bids received "on line" shall be opened at 15.30 Hours on 30.08.2025 in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of CoverII (BOQ) will be communicated in due—course of time to the—qualified bidders of Cover-I.
- 8. The bidders shall furnish the attested copies of the valid Contract Licence, Pan, GST, labour licence, Solvency Certificate from a Nationalised /Scheduled Bank issued within last 6 (Six) month, Copy of Balance Sheet and Turn Over for last Five Years(duly certified by a Chartered Accountant along with UDIN), list of works executed with in last five years, list of works in hand along with self-attested copies of supporting documents and Turn Over Certificates for last Five Years(duly Certified by Chartered Accountant with valid UDIN no.), Schedule-A to F & other documents as mentioned in DTCN.
- 9. Additional performance security shall be obtained from the bidder before drawl of agreement, he has to submit the Additional Performance Security for the amount as detailed below in Shape of Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of SE,CWC, OPTCL, BBSR at the time of agreement.

- 10. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
- 11. The packet super scribing the name of the work and containing cost of bid document & Affidavit in original and other documents may be submitted in the office of the undersigned on or before 15.00 Hours on dated 30.08.2025 during office hours on working days failing which the bid will be rejected
- The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank, payable at Bhubaneswar separately towards cost of each tender. The purchaser of the demand draft has to be the bidder himself or his authorised representative. In case of authorised representative, the bid must be accompanied by a affidavit/undertaking of authorisation.
- 13. E-Reverse Auction (if applicable) shall be held on <u>www.tenderwizard.com/OPTCL</u> amongst the technically qualified bidders who will be invited as per the terms laid in DTCN.
- 14. The bidders should have successfully executed at least a single similar nature of work, ie, work with sports complex/ Indoor Stadium worth work value of ₹ 6.50Crore or more during the last five financial years i.e. 2020-21,2021-22, 2022-23,2023-24 & 2024-25 in a single agreement. The bidders failing to produce authenticated document in support of work experience from competent authority is liable for rejection. Experience certificate from any Private Organisation will not be entertained. Experience certificate furnished below the rank of Executive Engineer of Government Department/Public Sector Undertaking will not be accepted. The original agreement in support of experience certificate submitted by the bidder may be verified before opening of the financial bid.
- 15. The bidder is required to furnish Solvency Certificate of ₹ 2.00 Crore for work from a Nationalised / Scheduled Bank issued within last Six(6) Months.
- 16. The bidders are to submit Balance Sheet and Turn Over Certificate of last 05(Five) financial years i.e. from 2020-21, 2021-22, 2022-23, 2023-24 and 2024-25 duly certified by Chartered Accountant with valid UDIN no.
- 17. EPF and ESI certificate with last 03 month (May to July 2025) updated challan is mandatory for qualification.
- 18. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
