- 7 Bid must be accompanied by E.M.D./Security of the amount specified for the work at column 04 in the above table in shape of National Saving Certificate /Kisan Vikash Patra/Post Office Savings Bank Account/ Post Office Time Deposit Account/ Deposit Receipt of Schedule Bank pledged in favour of Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhubaneswar.
- 8 The sale of the Bid documents shall be from **dt. 12.09.2025 to dt. 24.09.2025** during office hours (11:00 A.M to 5:00 P.M) except dtd. **24.09.2025** on which the time is fixed up to 2:00 P.M. The receipt of the same will be from **dt. 12.09.2025 to dt. 24.09.2025** up to 5.00 P.M during Office hours. **Close of receipt of Bid Documents will be on dt. 24.09.2025 at 5.00 PM.** Bid shall be received from the office of the undersigned where the bids have noticed to be sold.
- 9 Bid must be delivered in the tender box having identification NO. E.E. CWD- II, TENDER CALL NOTICE NO 01 of 2025-26.
- 10 Bid document can be purchased from the office mentioned in the table column 7 against a non-refundable fee towards cost of the documents as indicated in column 5 of the table in in shape of demand draft drawn in favour of the Superintending Engineer(Civil), Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank, payable at Bhubaneswar **separately** towards cost of each tender. The purchaser of Demand draft has to be the bidder himself or his authorised representative. In case of authorized representative, the bidder must be accompanied by an affidavit/undertaking of authorization.
- 11 Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500.00 over cost of documents. The Executive Engineer, Civil Works Division No-II, OPTCL, Burla will not be held responsible for the postal delay if any in the delivery of the documents or non-receipt of the same in time.
- 12 The Bids will be **opened on dated 25.09.2025 at 11:30 A.M.** in the office of the undersigned in the presence of the bidders or their authorized agent who wish to attend. If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.
- 13 The bidders shall furnish the attested copies of **all valid Registration Certificates like, PAN Card, GST Registration Certificate and Contract Licence** along with the Bid failing which his/her bid shall not be considered. The bidders shall have to furnish an affidavit in original for each work (Photocopy of affidavit not allowed) at the time of submission of the bid about the authentication of all the tender documents failing the bid shall be cancelled as non-responsive and thus liable for rejection.
- 14 The GST Registration Certificate of the agency must be included with both Supply & Service Provider otherwise the office could not sale the tender papers.
- 15 The bidder shall have to furnish EMD with the bid failing the bid shall be considered as non-responsive and liable for rejection.
- 16 The amount put to tender is inclusive of 1% Cess, which will be adjusted during payment of bills.
- 17 The bidder whose quoted rate is less than the estimated cost by more than 14.99% will be rejected.
- 18 Additional Performance Security shall be obtained from the bidder before drawl of agreement. He has to submit the Additional Performance Security for the amount as detailed below in shape of **National Saving Certificate/Kisan Vikash Patra/Post Office Savings Bank Account/ Post Office Time Deposit Account/ Deposit Receipt of Schedule Bank duly pledged in favour of the Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhubaneswar.**

- 20 Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference and for availing the facilities. The Security Deposit (Earnest Money, Initial Security and Performance Security) at half the usual rate may be deposited/ realised by/ from the Scheduled Caste or Scheduled Tribe Contractors coming under the categories up to 'B' Class only as against the prescribed percentage.
