

SECTION-II INSTRUCTION TO BIDDERS

The Bidders must read in detail the "Instruction to Bidders" and "General terms and conditions" before filling the tender documents.

1. (A) Sealed tenders are invited from the reputed firms/ agencies/ Contractor having GSTIN, PAN & sound financial capabilities.

(B) The Bidder should super scribe only the "Tender Call Notice No. & Date of Opening of the tender on the body of the Sealed Envelope". Bidder should not write their name or any other information on the body of the sealed envelope. Super scribing any other information on the body of the envelop, Conditional tender, Incomplete tender, Telegraphic / Fax / E-mail (etc.) Tenders & Tenders not accompanied with requisite amount of E.M.D. will be rejected. The authority reserves all rights to reject any, all or part of the Tender, alter/modify the requirement/ delete any part of the tender without assigning any reason thereof.

2. SCOPE:

The job covers "Providing temporary protective measures against land sliding & erosion in front of 220/33kV Switch yard in river face of Grid Sub-station of OPTCL at Kashipur with a temporary road of width 3.0 Mtr of length 150Mtr to reach the damaged area from the S/Y". The agencies has to arrange all the required men and materials at his own cost to complete the above mentioned job. The scope of work is variable from time to time within the contract period. For such variations the contractor shall immediately arrange to take up the work as per price at which order is placed.

3. SUBMISSION & OPENING OF TENDER:-

The bidder has to submit all the documents as mentioned in Clause No.08(A) of SECTION-II. Also the documents must valid on the date of opening of tender should be submitted along with tenders, failing which the tender will be rejected. The bidder or their authorized representatives should produce the original documents mentioned in Clause No.08(A) of SECTION-II for verification at the time of opening of the tender. Those who fail to produce the same and found not to be valid on the date of opening of tender not matching with the Xerox copy submitted by the bidder; their tenders will be out rightly rejected. Total of item and grand total of whole tender be clearly written.

Correction in the tender, if un-avoidable, should be made by re-writing with dated initial of the bidder after scoring out wrong entries, clerical and arithmetical mistakes may result in the rejection of the tender.

10. The bidder shall sign on all pages of the tender document as a token of acceptance of all terms and conditions thereof and submit his quotations therein.

11. The bidder shall quote the rates in the Price Bid of the tender documents. The rates quoted should be including of all taxes and duties but exclusive of GST.

The same shall be referred for arbitration to the Director (HRD) OPTCL, Bhubaneswar or any arbitrator appointed by the Chairman-Cum-Managing Director, OPTCL after due notice of claim and such appointment and the award of the arbitrator shall be final and binding arbitration and conciliation Act. 1996 shall apply. The venue of arbitration will be Bhubaneswar.

16. The EMD not claimed for refund within a period of one year from the date of issue of purchase order and security deposited not claimed for refund within a period of three years after completion of contract, will be forfeited.

SECTION-III GENERAL TERMS & CONDITIONS

- 1. Scope of contract: The scope of contract shall be "Providing temporary protective measures against land sliding & erosion in front of 220/33kV Switch yard in river face of Grid Sub-station of OPTCL at Kashipur with a temporary road of width 3.0 Mtr of length 150Mtr to reach the damaged retaining wall area from the S/Y" in accordance with the enclosed technical specification and schedule of requirement.
- <u>2. Manner of execution</u>: All materials should be supplied under the contract shall confirm to the latest publication of relevant IS specification.
- <u>3. Validity:</u> Tenderers are requested to keep the validity of their offer for a period of 6 months from the date of opening of tender.
- <u>4. Price:</u> The price quoted by tenderer should be firm, F.O.R. destination inclusive of freight, Insurance, Packing, Forwarding charges inclusive discount, if any.
- 5. Taxes: Taxes, if any shall be mentioned extra. The tender may quote rate in respect of different make materials as per scheduled.
- <u>6. Terms of Payment:</u> 100% payment with taxes etc. shall be made within 45 days after completion of the work & verification thereof by the consignee.
- 7. Penalty: If the agency/ contractor shall fail to complete the work period as stipulated under clause No. 5 (Section-II) of this Tender document or any extension granted there to, the purchaser shall recover from the agency/ contractor penalty for a sum of half percent (i.e. 0.5 percent) of the contract price for each calendar week or part thereof of delay. Guarantee: The materials covered under this contract should be guaranteed for trouble free and satisfactory performance against any defect in design, materials and workmanship for a Period of at least 12 (Twelve) months from the date of completion. Any defect noticed during this period should be rectified / replaced by the firm/ agency/contractor with free of cost provided such defects are due to faulty design, bad workmanship or bad materials used.

The replaced materials should also have similar guarantee. In the event of any breach on default in all or any condition of work order Security Deposit will be forfeited.

- 12. Insurance: Insurance of materials is to be done by the supplier at their own cost. The responsibility of delivery of the materials at destination in good condition rests with the supplier. Any claim with the insurance company Railway authority/ Road transport authorities arises due to loss or damage in transits has to be settled by the supplier. The supplier shall undertake free replacement of materials damage or lost which will be reported by the consignee within 30 Days of the receipt of the materials at destination without waiting for the settlement of the claims with the carriers.

- 14. Paying Officer: The DGM, EHT (Const.), Division, Rayagada is the paying officer for this contract.
- 15. Submission of GST Registration Certificate & PAN: Clear self-attested Xerox copies of PAN issued by the competent authority, GST Registration, certification valid on the date of opening of tender should be submitted along with the tender, failing which the tender will be rejected. The agency/contractor may be requested to produce original PAN card & GST Registration certificate at the time of opening of the tender.
