If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.
- 18 The bidders shall furnish the attested copies of **all valid Registration Certificates like, PAN Card, GST Registration Certificate and Contract Licence** along with the Bid failing which his/her bid shall not be considered. The bidders shall have to furnish an affidavit in original for each work (Photocopy of affidavit not allowed) at the time of submission of the bid about the authentication of all the tender documents failing the bid shall be cancelled as non-responsive and thus liable for rejection.
- 19 The GST Registration Certificate of the agency must be included with both Supply & Service Provider otherwise the office could not sale the tender papers.
- 20 The bidder shall have to furnish EMD with the bid failing the bid shall be considered as non-responsive and liable for rejection.
- 21 The amount put to tender is inclusive of 1% Cess, which will be adjusted during payment of bills.
- 22 The bidder whose quoted rate is less than the estimated cost by more than 14.99% will be rejected.
- 23 Additional Performance Security shall be obtained from the bidder before drawl of agreement.
