(SECTION-II) INSTRUCTION TO TENDERERS

- 1. Sealed tender duly super scribed as "TENDER AGAINST TENDER NOTICE No. 01/2020-21 are invited from experienced contractors with civil contractor license (C or D) issued by Govt. of Odisha /Govt. Of India railways/ Military for the work construction of RCC slab & laying on cable trench inside 400 kV S/Y at Grid S/S, Meramundali as per the technical specification enclosed to be received in this office on or before 3.00 P.M. Dt. 26.02.2021 and the same shall be opened on Dt. 26.02.2021 at 3.30 PM in presence of the Tenderers or their authorized agents if any. Tenders received after 3.00 P.M. on Dt. 26.02.2021 will not be accepted, since the tender box will be closed at 3.00 P.M.
- 2. Tender shall be submitted duly signed in each page by the authorized signatory in a sealed cover envelope addressed to the Dy. General Manager, EHT (O&M) Division, Meramundali, At-Kantabania, Po-Kusupanga, Dhenkanal-759121. All the documents submitted along with the tender must be signed and certified by the authorized signatory of the bidder.
- 3. No telegraphic tenders/forwarding by FAX will be accepted.
- 4. This office will not be responsible for non-receipt/late receipt of the tender documents due to postal delay.
- 5. The tenders shall be furnished strictly as per the terms and conditions of the tender specification. Incomplete tenders will be rejected.
- 6. The Authority may alter the quantum of work at the time of placing orders. Orders may also be split up among more than one tenderer depending upon necessity & urgency.
- 7. Only those, who have purchased the tender specification from this office by their name/Firm's name, can submit their tender. Tenders submitted by others will be rejected.
- 8. Tenders will be submitted in person/by registered post with A.D. Tenders submitted by any other means shall not be accepted. Postal delay shall not be considered. Tenders received after due date and time shall be returned un-opened.
- 9. (i) The tender shall be accompanied with **earnest money** of Rs. 10000.00 (Rupees Ten Thousand only) in shape of Cash/Bank Draft drawn in favor of the, **EHT (O&M) Division, OPTCL, Meramundali**, Payable at "STATE BANK OF INDIA", Bhushan Steel Plant, Narendrapur Branch without which their tender shall be rejected. Cheques will not be accepted.

- 10. The authority reserves the right to reject the lowest or any other tender or all tender without assigning any reason what-so-ever.
- 11. Offers should be neatly typed without any overwriting and corrections.
- 12. In the event of discrepancy or arithmetical error in the bid, the decision of the purchaser shall be final and binding on the tenderer.
- 13. For evaluation, the price mentioned in words shall be taken, if there is any difference in figure and words in the price bid.
- 14. Conditional tender shall not be accepted and no discount other than the quoted price will be allowed as mentioned in the original offer.
- 15. The tenderers are advised to visit the site and make them acquainted with the site condition before submission of tender.

(SECTION-III) GENERAL TERMS & CONDITIONS OF CONTRACT

Sealed tenders are invited in duplicate from intending Bidders having valid CIVIL Contract License with PAN and GST Registration for construction of RCC slab & laying on cable trench inside 400 kV S/Y at 400/220/132 kV Grid S/S, Meramundali under EHT (O&M) Division, Meramundali.

- **1. SUBMISSION & OPENING OF TENDER: -** Tender shall be submitted with other documents in duly sealed envelope super scribed on the body of envelope "Tender for construction of RCC slab & laying on cable trench inside 400 kV S/Y at 400/220/132 kV Grid S/S, Meramundali". The bidder should write only Tender Specification No, the name of work and date of opening of the tender on the body of the sealed envelope. Bidder should not write their name or Agency name on the body of the sealed envelope which may make the offer liable for rejection.
- **2. RIGHT & AUTHORITY FOR REJECTION:** Tenders received after due date and time will be summarily rejected. The General Manager (Electrical), E.H.T. (O&M) Division, Meramundali reserves the right to reject any or all of the tenders without assigning any reason thereof.
- **3. VALIDITY OF OFFER: -** The offer should be firm and valid for a period of at least 120 days from the date of opening of tenders. Unless the tender will be rejected.
- **4. EARNEST MONEY DEPOSIT:-** The tender should be accompanied with Rs. 10,000.00 (Rupees Ten Thousand only) towards Earnest Money Deposit (EMD) in shape of **Cash/Bank Draft** in favour of **EHT** (**O&M**) **Division, OPTCL, Meramundali**, Payable at "STATE BANK OF INDIA", Bhushan Steel Plant, Narendrapur Branch otherwise tender will be out rightly rejected. In case the B.D made any other nationalized bank payable at any clearing branch at Talcher/Angul will be allowed, but the bidders have to deposit the collection fee (Bank transaction fee) along with the EMD. The collection fee is Non-refundable & It can't be taken into account of EMD deposit. The EMD of the unsuccessful bidders will be returned after finalization of tender. The EMD of the successful bidders will be returned only after the Security money deposited as per the clause No. (6) in Section (III). In case of successful bidder fails to execute the order satisfying all terms & conditions or also fails to commencement of work within stipulated date mentioned in the date of order, the Earnest Money Deposit will be forfeited. No interest will be paid on the EMD to any participator. No other mode than above for EMD Deposit will be accepted & bidder will be out rightly rejected.
- **5. PRICE:-** The bidders are advised to quote their rate as per the price schedule in Section-V with break up prices including of all Taxes & Duties and shall remain up to the validity of tenders.
- **6. SECURITY DEPOSIT:** The bidders whose offer qualifies for acceptance will be awarded work order for execution of the works and the bidder shall have to deposit security amount equal to 10% (ten percent) of contract value in shape of cash/bank draft drawn in favour of respective paying officer, of OPTCL, The security deposit shall be released after two months of the guarantee period as stated under clause-10 of SECTION-III on receipt of application for this purpose. No Interest shall be paid to the bidder towards the security deposit so deposited by the Bidder. The security deposit shall be deposited with the respective paying officer of OPTCL prior to commencement of work. The security deposit shall be released after expire of Guarantee period. In case of Non-fulfilment of contractual obligation by the supplier, the same so deposited shall be forfeited.
- **7. COMMENCEMENT & COMPLETION OF WORK:** The works awarded should be commenced from 15 days of the award of the contract and completed within 60 days. If the work could not be

completed within scheduled date due to any valid reason, then completion period may be extended on written request by the Bidder. If the work will not commence & complete within the stipulated period, then the penalty should be imposed as per clause No.08 of SECTION-III.

- **8. PENALTY:** Penalty @ ½%(half per cent) per week up to a maximum of 5% of the total value of the work order will be imposed and recovered from dues admissible if the work will not completed within the specified date in SECTION –III, clasue-7. However imposition of penalty clause is subject to force majeure condition.
- **9. TERMS OF PAYMENT: -** 100 % (one hundred percent) payment along-with full taxes and duties (if any) shall be made after successful completion of the work in all respect and verification reports thereof by respective consignee and Paying Officer and on receipt of funds from Head Office in this regard. After complete execution of work, the bidder shall produce the printed bills to the respective consignee/Paying Officer for effecting payment. No part payment or running bill is allowed without completion of work in all respect.
- **10. GUARANTEE PERIOD: -** The work done by the contractor as per contract specification should be guaranteed for satisfactory operation and against any defects, in materials & the workmanship for a period of 18 months from the date of completion of the work or 12 months from the date on which material has been put to service, whichever is earlier. The above guarantee certificate shall be furnished in triplicate to the undersigned for approval. Any defects noticed during the period shall be rectified by the contractors at its own cost, without any financial burden to OPTCL.
- **11. DOCUMENTS: -** The following Xerox copy should be submitted with the tender paper & the same will be verified with original documents at the time of opening of tender.
 - i) Civil Contract License (class C & D)
 - ii) GST Registration Certificate.
 - iii) Valid PAN/ TIN.
 - iv) Experience Certificate (optional)
- **12. ADDITION OR DELETION OF CONTRACT: -** The Contract may be altered in quantum as per exigencies of work. The bidder shall accordingly provide services as may be required by the Officer- in Charge on being given a notice of 15 days
- **13. ARBITRATION: -** In the event of any dispute arising out his contract. The same shall be referred for arbitration to the Director (HRD) OPTCL, Bhubaneswar or any arbitrator appointed by the Managing Director, OPTCL after due notice of claim and such appointment and the award of the arbitrator shall be final and binding arbitration and conciliation Act. 1996 shall apply. The venue of arbitration will be Bhubaneswar.
- **14. CONSIGNEE:** The AGM/Manager, 400/220/132 kV Grid S/S, Meramundali is the consignee for the contract.
- **15. PAYING OFFICER:** The DGM, EHT (O&M) Division, Meramundali is the paying Officer for contract.
- **16. JURISDICTION OF COURT: -** Suits if any, arising against the work order to be issued to the Bidder shall be filled by either party in any court of law to which the jurisdiction of Odisha High Court extends.

- 17. **SAFETY PRACTICE:** The Bidder must be followed the OPTCL safety Rule while performing the work. The workmen must be provided with Safety equipment by the contractor while performing the works .No deviation will be allowed and the consignee has got any power to stop the work at any time on the breach of safety practice.
- 18. **OUTRIGHT REJECTION OF TENDERS:** The tenders shall be liable for outright rejection if the following have not been complied.
 - a) Tenderers should have purchased the tender specification from the office of the D.G.M., EHT (O&M) Division, Meramundali-759121 in his own or Firm's name.
 - b) Tenders shall be submitted in person or by Registered post with A.D. and received before the time fixed for receipt of tender.
 - c) Tenders shall not be submitted telegraphically or by FAX.
 - d) Tenders shall be accompanied with the prescribed earnest money deposit.
 - e) Tenders shall be kept valid for a minimum of 120 days from the date of opening of the tender.
 - f) Tenders shall be accompanied with clear valid attested Xerox copy of PAN No., ITCC as well as Civil contractor's license which must be valid on the date of opening of the tender. All copies of documents and each page of the tender must be signed by the authorized representative of the bidders.
 - g) The contractor agreed to obtain Labour Contract License on event of work order from the competent authority.
 - h) The tender shall not be conditional.
 - i) The tenderers shall fill the information at Annexure-II of this tender specification.



TECHNICAL SPECIFICATION (With Drawing)

The Scope of work: - The scope of works must covers the followings & as per Drawing.

- i) Specification of RCC Slab mentioned in Table and all other dimensions are as per drawing mentioned below.
- ii) Steel having IS-1786 shall be used of any reputed brand which are established, reliable, indigenous and primary producer of steel having integrated steel plant (ISP), using iron ore as basic raw materials as per ministry of steels guideline. No re rolled steel shall be permitted in work.
- iii) 53 grade cement shall be used of any reputed manufacturers of cement inside the state.
- iv) Pond watering shall be provided for RCC work as per the instruction of site in-charge. The contractor has to arrange adequate supply of clean water required for the work whenever necessary at his/her own cost.
- v) The successful bidder shall make his own arrangement for all materials and T&Ps such as concrete mixture, vibrator, PRR etc. for the work.
- vi) The quoted rate for the work will deem to include all incidental items which may necessary for construction of benchmarks, level pillars, profiles, benching levels of the ground etc. where required. No extra payment or claim will be admissible on this ground.
- vii) Cleaning of debris where necessary shall be considering as incidental to the work and shall be contractor's responsibility to clean it.
