For and on behalf of OPTCL, the General Manager (Elect.), E.H.T (C) Circle, OPTCL, Rayagada pleased to invite sealed openTender / Bids from reputed Goods Transport Agencies (GTA) having valid GSTIN & PAN for execution of the work “Transportation with Loading and Un-loading of E.H.T Materials from E.H.T Store Sub-Division, Banarpal and 132/33kV GSS, Muniguda to 132/33kV GSS, Lamataput and 220/33 GSS, Govindpalli (for 220kV Govindpalli LILO line)” which shall confirm to the terms & conditions as detailed below. The last date of the receipt of the quotation is 26.06.2025 up to 3.00 PM and will be opened at 4.00 PM at the office of the undersigned.

TERM& CONDITIONS

1. **Scope of works:** Transportation along with loading & Unloading of (as per Annexure-III);

- 15.2 MT of E.H.T. materials (i.e ACSR Zebra Conductor) from E.H.T Store S/D, Banarpal to 220/33kV GSS, Govindpalli for 220kV Govindpalli LILO line. (To & Fro = 573 X 2 = 1146 Kms)
- 5.255 MT of E.H.T Materials from E.H.T Store Sub-Division, Banarpal to 132/33kV GSS, Lamataput and Govindpalli via Muniguda GSS and back to Banarpal. (Total Distance to & Fro= 679+573 = 1252 Kms)

All the material, T&P as required for the above work along with labour etc. will be provided by the contractor/Firm.

- Validity:** The tenderers are requested to keep the validity of their offer for a period of 30 days from the date of opening of limited tender.
- Price:** The bidders are advised to quote their rate as per the price schedule attached at Annexure-I and shall remain firm inclusive of all duties, labour charges etc., within the validity of tenders.
- Completion of works:** The works awarded should be completed in all respect within 30 days from the date of placement of work order.
- Penalty:** Penalty should be imposed @ ½ % (half percent) of contract price for each calendar week of delay or part thereof subject to maximum of 5% (five percent) of contract amount. Penalty shall be counted after date scheduled for completion / issue of clear instruction to the contractor for commencement of work.

6. **Terms of payment:** 100% (Hundred per cent) payment along with full taxes and duties (if any) shall be made after successful completion of the work in all respect and verification thereof by respective consignee and Paying officer subject to submission of bills after deduction of taxes as per statutory norms.
7. **Toll Gate charges:** - The toll gate charges will be reimbursed. The receipt of payment shall be enclosed along with the bills.
8. **Consignee:** The SDO (Elect.), EHT (Construction) Sub-Division, Jeypore shall be the Consignee & verifying officer for the work.
9. **Paying Officer:** The DGM (Elect.), EHT (Construction) Division, Jeypore.
10. **Submission of PAN & GSTIN registration certificate:** Clear attested Xerox copies of PAN No., GST Registration Certificate, valid on the date of opening of tender, should be submitted along with tenders, failing which the tender will be rejected. The contractor may be requested to produce original PAN Card & GST Registration Certificate for verification at the time of opening of the tender. Those who fail to produce the same and found not to be valid on the date of opening of tender, their tenders will be rejected.
11. **Variations, additions and omissions:** The OPTCL shall have the right to alter, amend, omit or otherwise vary the quantum of work by notice in writing to the Contractor. The Contractor shall carry out such variation in accordance with the rates specified in the contract.
12. **Supervision of the work:** The above work should be executed under the supervision & instruction of the SDO (Elect.), EHT(Construction) Sub-Division, Jeypore.
13. **Workmen's compensation:** The contractor shall be fully responsible for paying compensation if any under the Workmen Compensation Act on account of workmen deployed by him.
14. **Rejection of works:** The undersigned reserves the right to reject any or all tenders without assigning any reason thereof.
15. **Payment due from the contractor:** The Transporter shall be liable for all costs, damages, charges and expenses suffered or incurred by the OPTCL due to the Contractor's / Transporter's, negligence and un-workman like performance of any service under this Contract and for all damages or losses occasioned to the OPTCL or in particular to any property belonging to the OPTCL due to any act whether negligent or otherwise of the Transporter or its employees. All costs and damages for which the Contractor is liable to the authority will be deducted by him from any money due to the Contractor under the contract.
16. **Contractor's responsibility:** The Bidder must be fully acquainted with the site and location of the loading and unloading points before quoting rates and submitting bids. Once the bid is submitted by the bidder, he/she shall not be entitled to any compensation arising out of any discrepancy in the site and location found later on, or on the grounds that the workers employed by him/her are demanding higher rates of wages in respect of certain operations. Notwithstanding anything mentioned in the specification or subsequent approval or acceptance of the work by OPTCL, the ultimate responsibility for satisfactory performance of the work shall rest with the contractor.
17. **Non-assignment:** The contractor shall not assign or transfer the work order issued as per this contract or any part thereof without the prior approval of OPTCL.
18. **Jurisdiction of court:** Suits if any, arising against the work order to be issued to the contractor shall be filed by either party in any court of law to which the jurisdiction of Odisha High Court extends.
19. **EMD:** The firm has to deposit EMD amount of ₹ 1700/- in shape of Cash.
20. **General Terms & Conditions:**
 - i. The tender / bid shall be submitted in person or by Registered Post with A.D which should be

- received before opening of tender i.e. on or before **26.06.2025** up to **3.00 PM**.
- ii. Tender shall be accompanied with clear valid attested photo copy of GTA certificate, I.T. PAN, GST Registration Certificate, which must be valid on the date of opening of tender.
 - iii. Details of Contractor shall be filled in Annexure-II.
 - iv. The tenderer should put their signature in each page of the tender specification.
 - v. The purchaser reserves the right to reject the lowest or any other Tender or all tenders without assigning any reason whatsoever.
 - vi. Tender should be prepared clearly and without any overwriting and corrections. Erasures and other changes shall bear the dated initial of the person signing the Tender.
 - vii. In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the tenderer. For evaluation, the price mentioned in words shall be taken if there is any difference in figure and word in the price bid.
 - viii. The Authority reserves the right to award the contract among any responsive bidders against this tender. The authority reserves the right to reject any or all the tenders and alter the quantum of works without assigning any reason thereof.


