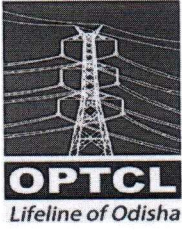

Sealed tenders are invited by the undersigned from intending Bidders having PAN, GST Registration Certificate and Civil contractor license for **“Sinking of bore well (8 inch dia.) with provision of pump set & accessories including laying of pipes at 132/33KV GSS, Barpali under EHT(O&M) Division, Barpali”**. As per the details in tender specification.

The tender specification can be obtained from the office of The D.G.M. E.H.T. (O&M) Division, Barpali on payment of **Rs. 2000/-(Two Thousand only)+ GST @ 18% i.e Rs. 2,360.00 (Non Refundable)** in shape of Bank Draft in favor of **EHT O&M Circle OPTC Ltd., Burla** payable at **“ Union Bank”, Burla**, (During Office hour) from **Dt.23.05.2025 to 06.06.2025**. In case the B.D. made in any other nationalized bank payable at any clearing branch at Burla will be allowed, but the bidders have to deposit the collection fee (Bank transaction fee) along with the paper cost. The collection fee & Paper cost is Non-refundable. Additional amount of Rs.100/-(One Hundred only) may be paid extra for postal delivery of the tender specification. The undersigned shall not be held responsible for any postal delay.

The Tender shall be received Up to 13:00 Hrs. on dated 09.06.2025 & will be opened at 15:30 Hrs. on Dt.09.06.2025 in the Office of the undersigned in the presence of the Bidders (or) their Authorized Representatives present if any. If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D. @ 1% of the estimated value i.e. **Rs. 3460.00** should be deposited in shape of Demand Draft in favour of **EHT(O&M) Circle, OPTC Ltd. Burla** & payable at **“ Union Bank”, Burla** Branch along with self-attested copy of PAN Card, GST Registration certificate and valid Civil Contractor license, failing which the tender will be liable for rejection.

Bidder should not write their name or any other information on the body of the sealed envelope. 
