Sub: Clarification regarding supporting angles for Cable Trays and extension of bid submission schedule against e-Tender Call Notice No. 04/25-26.

This is to notify that, based on the queries raised by prospective bidders, the details of supporting GI angles for Cable Trays against Item Nos. 3, 4 & 5 of the Bid Sheet are hereby clarified as follows:

Sl. No.	Particular	Specification
1	Size of GI Angle	50 × 50 × 6 mm
2	Length of each supporting angle	Width of Cable Tray + 100 mm, i.e., 400 mm for Item No. 3, 300 mm for Item No. 4 and 200 mm for Item No. 5
3	Spacing of supporting angles	One supporting angle at every 1.0 metre along the length of the cable tray
4	Material Specification	Hot-dip galvanized GI Angle with minimum zinc coating 610 GSM/sqmtr conforming to the relevant Indian Standards (IS)


The bidders shall quote their rates **per running metre** as per the Bid Sheet. The quoted rate shall be inclusive of the cost of the Cable Tray and the required supporting GI Angles as specified above. Further, the schedule for the above-mentioned tender is hereby extended as detailed below:
