But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The Bids received "on line" shall be opened at 11.00 Hours on dtd.17.10.2022 in the office of the Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on at the date of opening of Bids as specified, the bids will be opened on the next working day.
- The bidders shall furnish the self-attested copies of Contract License, PAN, GSTIN and other documents as mentioned in clause no 26 of the DTCN. They may go through the outright rejection criteria as mentioned in DTCN.
