- The Cover-I (Techno-Commercial Document) of the Bids received "on line" shall be opened 8. at 11.00 Hours on 12.06.2025 in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to bidders who participated in the bid can witness the opening of bids after logging thesite through on to their DSC. The packet super scribing the name of the work and containing cost of bid document & Affidavit in original and other documents may be submitted in the office of the undersigned on or before 17.00 Hours on dated 11.06.2025 during office hours on working days failing which the bid will be rejected
- The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank, payable at Bhubaneswar separately towards cost of each tender. The purchaser of the demand draft has to be the bidder himself or his authorised representative. In case of authorised representative, the bid must be accompanied by a affidavit/undertaking of authorisation.
