On behalf of OPTCL, Superintending Engineer(Civil), Civil Works Circle, OPTCL, BBSR ,invites quotes from interested reputed Structural / Consultant firms for providing Engineering services to carry out "Consultancy services for Drawing and Design of Standard Gate complex for OPTCL" in two parts i.e. Technical bid and Price Bid.

2. QUALIFICATION CRITERIA:

- The firm must be an architectural/structural/consulting firm having valid GSTIN & PAN. Firm registered as Architectural / consulting firm under MSME would have added advantage.
- The firm must have architects with valid liscence. 2.2

Interested service providers who meet the pre-qualification criteria may furnish their quotes with all the necessary documents in a sealed cover from 22.07.2024/11.00 am to 30.07.2024/3.00 PM.

3. SCOPE OF WORK:

The scope of the work broadly includes the followings:

- 3.1 Preparation, finalization and submission of 3-D rendered architectural design of gate and Security complex and detail layout drawings of the project in consultation with Concerned Engineer of OPTCL, BBSR.
- 3.2 Submission of structural design and drawings of all the structures duly prepared by structural engineer.
- 3.3 Submission of final detailed drawings for tender.
- 3.4 Submission of detail estimate for the projects based on Odisha Schedule of Rates with rate analysis for approval of the estimate.
- 3.5 Submission of bill of quantity for technical sanction and inviting tenders.

4. SUBMISSION OF BID

- 4.1 The last date of receipt of the bid document by speed post/Regd. Post/in person in the office of S.E(Civil) is 30.07.2024/3.00 PM at SE(Civil), OPTCL, Bhubaneswar, will not be responsible for any postal delay, whatsoever bids received after the due date and time will be rejected. If any of the above dates fall on holiday(s), the next working day will be treated as the effective date.
- 4.2 The finally selected bidder has to submit an Initial Security Deposit (ISD) of Rs.5,000.00 (Rupees Five Thousands Only) in shape of NSC/KVP/TDR /BG(Annexure1) of any nationalised Bank drawn and duly pledged in favour of "The SE(Civil), Civil Works Circle, OPTCL, Bhubaneswar" valid till the end of the project before drawl of agreement.
- 4.3 The bidders are to sign all the pages of the bid document with their seal.
- 4.4 The bidder must attach a 3-D view of Proposed Gate complex along with bid.
- 4.5 Conditional offers from bidders will not be entertained.
- 4.6 Corrigendum if any shall be published in the OPTCL website only, ie., www.optcl.co.in.

5.INSTRUCTION TO THE BIDDER

- 5.1 The bidders are required to submit the technical and financial bids in two separate sealed packets, repacked in one sealed packet so as to reach to Office of the Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhubaneswar, Bhoinagar, Unit-9, Pin-751022 within the stipulated time as mentioned above.
- 5.2 The technical bid should contain all documents as mentioned in (Technical Evaluation). Proforma I, VII & Proforma VIII duly filled. Non submission of any of the document will lead to technical disqualification.
- 5.3 The financial offer should be only Lumpsum basis as per Proforma VI .However the GST applicable will be paid extra.
- 5.4 The bidders are required to submit the partnership deed in case of partnership firms and Articles of Association in case of Limited Company.
- 5.5 Bid submitted by participants shall remain valid for acceptance for a minimum period of 90 days from the date of the opening of the tenders.
- 5.6 Corporation does not bind itself to accept the lowest tender.
- 5.7 It will be obligatory on the part of the tenderer to sign the tender documents for all the components & parts. After the work is awarded he will have to enter into

an agreement with Executive Engineer (Civil), Civil Works Division-I,OPTCL, Bhubaneswar for the awarded work within 07 days of receipt of acceptance of the tender.
