- 1. For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the <a href="http://tenderorissa.gov.in">http://tenderorissa.gov.in</a> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).
- 2. The bidders may submit bid for the works as per the following table:-

- 4. Bid security declaration- If the bidder withdraws or modifies his bid during the validity period, he will be suspended for a time period of 1 year.

- 5. The Bid documents will be available in the <a href="http://tendersorissa.gov.in">http://tendersorissa.gov.in</a> from 11.00 Hours of 31.08.2021 to 20.09.2021 up to 17.00 Hours
- 6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-III or Class-III.
- 7. Bids shall be received only "online" on or before 17.00 Hours of 20.09.2021
- 8. The Cover-I (Techno-Commercial Document) of the Bids received "on line" shall be opened at 11.00 Hours on 22.09.2021 in the office of the Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of Cover-II(BOQ) will be communicated in due course of time to the qualified bidders of Cover-I.
- 9. The bidders shall furnish the self-attested copies of Contractor License, PAN, GSTIN and other documents as mentioned in the DTCN. They may go through the outright rejection criteria as mentioned in the DTCN.
- 10. Additional performance security shall be obtained from the bidder **before drawl of agreement**, he has to submit the Additional Performance Security for the amount as detailed below in Shape of Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of **EE,CWD-II, OPTCL, Burla at the time of agreement.**

- ISD (Initial Security Deposit) value is 1% of the bid amount and is to be deposited by the contractor before drawl/signing of the agreement in the shape Bank Guarantee/NSC/KVP/Term Deposit Receipt pledge in favour of EE,CWD-II, OPTCL, Burla at the time of agreement.
- 12. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference and for availing the facilities. The Security Deposit(Earnest Money, Initial Security and Performance Security) at half the usual rate may be deposited/ realised by/ from the Scheduled Caste or Scheduled Tribe Contractors coming under the categories upto "B" Class only as against the prescribed percentage.
- 13. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.

- 14. The packet super scribing the name of the work and containing cost of bid document in original and other documents may be submitted to the office of the undersigned physically or by post(speed post/registered post only) on or before 17.00 Hours on dated 21.09.2021. The undersigned shall not be responsible for only postal delay. The Cover-I shall be opened on dated at 11:00 Hrs of 22.09.2021.
- The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank mentioned, payable at Bhubaneswar **separately** towards cost of each tender.
- 16. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
- 17. Before tendering, the bidder may visit the sites and satisfy himself, as no claim what-so-ever shall be entertained for any alleged ignorance, after the tender is opened.

- 20. The amount put to tender is inclusive of 1% cess which will be adjusted during payment of bills .The contractor shall have to produce labour licence within seven days of agreement if required by the undersigned
