Corrigendum to ETCN-06/2026-27

The Tender Paper ETCN-06/2026-27 for the work "Supply of different types and capacity of Fire Extinguishers (Make – Ceasefire, Kanex, Minimax or equivalent reputed make) for different Grid Sub-Stations under EHT (O&M) Circle, Berhampur" has been changed as followed:-

1. B.G. towards security deposit, 100% payment and performance guarantee:

[i] A Composite Bank Guarantee as per the Preform enclosed at Annexure-III of the specification for 10% [Ten percent] of the total contract value shall be furnished from any nationalized/scheduled bank having a place of business at Bhubaneswar, to the office of **General Manager, EHT (O&M) Circle, OPTCL Berhampur** within 15 days from the date of issue of the Purchase Order. The BG shall be executed on non judicial stamp paper worth of Rs.50.00 [Rupees fifty] only or as per the prevalent rules, valid for a period of 14 months from the last date of stipulated work completion period, for scrutiny and acceptance, failing which the work order will be liable for cancellation without any further written notices. The BG should be accompanied by a confirmation letter from the concerned bank and should have provision for encashment at Bhubaneswar, before the Bank Guarantee is accepted and all concerned intimated. The B.G should be revalidated as and when intimated to you to cover the entire guarantee period.

[ii] No interest is payable on any kind of Bank Guarantee.


[iii] In case of non-fulfillment of contractual obligation, as required in the detailed purchase order/Specification, the composite Bank guarantee shall be forfeited.

2. SECURITY DEPOSIT: -The successful Tenderer has to deposit 10% of the contract value as Security Deposit within 15 days of issue of purchase order. In case of non-execution of order the Security Deposit shall be forfeited. The Security Deposit amount will be refunded after successful completion of the guarantee period. The security deposit shall not carry any interest. If not deposited as per clause no.12, than it will be deducted from the bill while payment.
