#### (SECTION-II) GENERAL TERMS AND CONDITIONS OF CONTRACT [G.T.C.C.]

#### 1. Scope of the contract:

To carry out the work of oil arresting in different capacity of transformers at different Grid Sub-Stations under EHT (O&M) Division, Chatrapur.

#### 2.0 Definition of terms:

For the purpose of this specification and General Terms and Conditions of contract [GTCC], the following words shall have the meanings hereby indicated, except where otherwise described or defined.

- 2.1 "The Purchaser" shall mean the General Manager, EHT (O&M) Circle, Berhampur for and on behalf of ODISHA POWER TRANSMISSION CORPORATION LTD., Bhubaneswar.
- 2.1.1 "The Engineer" shall mean the Engineer appointed by the Purchaser for the Purpose of this contract.
- 2.2 "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
- 2.4 "The Contractor" shall mean the bidder whose bid has been accepted by the purchaser and shall include the bidder's executives, administrators, successors and permitted assignees.
- 2.5 "To carry out the work of oil arresting in different capacity of transformers at different Grid Sub-Stations under EHT (O&M) Circle, Berhampur including supply of materials, labour charges etc. to be done under the contract by the Contractors.
- 2.6 "Contract Price" shall mean the sum named in or calculated the bid.
- 2.7 "General Condition" shall mean these General Terms and Conditions of Contract.
- 2.8 The Specification" shall mean both the technical as well as commercial parts of the specification annexed to or issued with GTCC and shall include the schedules.
- 2.9 "Month" shall mean "Calendar month".
- 2.10 Writing" shall include any manuscript, type written, printed or other statement reproduction in any visible form and whether under seal or under hand.
- 2.11 "FOR Destination costs" shall mean the cost at our work site. The cost is inclusive of all taxes & duties etc., but excluding GST.
- 2.12 The term "Contract document" shall mean and include GTCC, specifications, form of tender, Notice Inviting Tender, covering letter, schedule of prices or the final General Conditions, any special conditions, applicable to the particular contract.
- 2.13 Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that in the ODISHA General Clauses Act.

#### 3. Manner of execution:

The works awarded should be completed within stipulated days as per work/purchase order.

#### 4. Language and measures:

All documents pertaining to the contract including specifications, schedule, notices, correspondence, operating and maintenance instructions or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

#### 5. Right to reject/accept any tender:

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the

interest of the OPTCL. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantities of work at the time of placing final work order.

#### 6. Force Majeure:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall within Ten (10) days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

#### 7. Extension of time:-

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

#### 8. <u>Guarantee period: -</u>

The work done by the contractor shall be guaranteed for a period of 12 months from the date of completion of work against any bad materials used and bad workmanship done for the work. The above guarantee certificate shall be furnished to the ordering authority for his approval. Any defects noticed during this period shall be rectified by the contractor, free of cost to OPTCL within one month, upon written notice from OPTCL provided such defects are due to bad materials used and bad workmanship.

The work failed or found defective during the guarantee period shall have to be guaranteed after rework for a further period of 12 months from the date of completion of work. The Bank Guarantee is to be extended accordingly without any financial burden to OPTCL.

#### 9. GST REGISTRATION No., PAN CARD:

Scanned copies of PAN, GST Registration No., experience certificate/ work order should be submitted along with tender document bid, falling which the tender will be rejected. The contractor or their authorized representatives should produce the original documents for verification at the time of opening of tender. Those who fail to produce the same and found not to be valid at the time of verification, their tenders will be rejected.

#### 10. B.G. towards security deposit, 100% payment and performance guarantee:

A Composite Bank Guarantee towards security deposit as per the Proforma enclosed at Annexure-III of the specification for 03% [ten percent] of the total contract value shall be furnished from any nationalized/scheduled bank to the office of concerned **DY. General Manager EHT (O&M) Divisions Chatrapur** within 15 days from the date of issue of the work order,. The BG shall be executed on non- judicial stamp paper worth of **Rs.29.00 [Rupees Twenty Nine] Only** or as per the prevalent rules, valid for a period of 14 months from the last date of stipulated work completion period, for scrutiny and acceptance, failing which the work order will be liable for cancellation without any further written notices. The BG should be accompanied by a confirmation letter from the concerned bank, before the Bank Guarantee is accepted and all concerned intimated. The B.G should be revalidated as and when intimated to you to cover the entire guarantee period.

[ii] No interest is payable on any kind of Bank Guarantee.

[iii] In case of non-fulfillment of contractual obligation, as required in the detailed Work order/Specification, the composite Bank guarantee shall be forfeited.

#### 11. Terms of Payment

- i. 97% of the bill will be paid after satisfactory completion of work and verification there off by E.I.C. The bills in triplicate in prescribed proforma may be submitted to the Engineer-in-charge after completion of work in all respect and due verification.
- ii. Balance 03% shall be paid against Bank Guarantee within 15 days from the date of issue of the work order or the equivalent amount will be deducted from the bill . The BG so furnished shall be treated as **work performance**

**security** and shall be released after completion of Guarantee and validity period. The BG shall be valid two months more than the Guarantee period. **The bill will send for pre-audit after being passed at Division office for payment.** 

#### 12. Penalty for Delay in Completion of Contract

Penalty shall be imposed @ ½% (half percent) of contract price for each calendar week of delay of part thereof subject to maximum of @ 5% (five percent) of contract amount. Charges towards penalty shall be counted after scheduled date of completion/issue of clear instruction to the contractor for commencement of works by the General Manager, E.H.T (O&M) Circle, Berhampur /concerned Dy. General Manager, (O&M) Division, Berhampur/Chatrapur.

#### 13. Validity
