1. Submission of Bids:-

The bidder shall submit the bid in Electronic Mode only i.e **www.tenderwizard.com/OPTCL**. The bidder must ensure that the bids are received in the specified website of the OPTCL by the date and time indicated in the Tender notice. Bids submitted by telex/telegram will not be accepted. No request to collect the Bids in physical form will be entertained by the OPTCL.

The OPTCL reserves the **right to reject any bid, which is not submitted documents** according to the instruction, stipulated above. The participants to the tender should be registered under GST/IT Act.

2. **Purchaser’s Right Regarding Alteration of Quantities Tendered.**

The Purchaser may alter the quantities of materials/equipment at the time of placing orders. 5. **Validity of the Bids: -**

6. PRICE: -

The bidders are advised to quote their rate as per the price schedule attached with specification and shall remain firm inclusive of all taxes & duties, labour charges etc. within the validity of the tender. However GST will be paid extra as per Govt. Prevailing rule.

7. Bidders to be fully conversant with the clauses of the Specification:

GENERAL TERMS AND CONDITIONS OF CONTRACT [G.T.C.C.]

1. DEFINITION OF TERMS:

- i. For the purpose of this specification and General Terms and Conditions of contract [GTCC], the following words shall have the meanings hereby indicated, except where otherwise described or defined.
- ii. "The Purchaser" shall mean the General Manager, EHT (O & M) Circle, Chainpal for and on behalf of ODISHA POWER TRANSMISSION CORPORATION LTD., Bhubaneswar.
- iii. "The Engineer" shall mean the Engineer appointed by the Purchaser for the Purpose of this contract.
- iv. "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
- v. "The Contractor" shall mean the bidder whose bid has been accepted by the purchaser and shall include the bidder's executives, administrators, successors and permitted assignees.
- vi. "Contract Price" shall mean the sum named in or calculated the bid.
- vii. "General Condition" shall mean these General Terms and Conditions of Contract.
- viii. "The Specification" shall mean both the technical as well as commercial parts of the specification annexed to or issued with GTCC and shall include the schedules.
- ix. "Month" shall mean "Calendar month".
- x. "Writing" shall include any manuscript, type written, printed or other statement reproduction in any visible form and whether under seal or under hand.
- xi. "FOR Destination costs" shall mean the cost at our work site. The cost is inclusive of all taxes & duties etc., but excluding GST.
- xii. The term "Contract document" shall mean and include GTCC, specifications, form of tender, Notice Inviting Tender, covering letter, schedule of prices or the final General Conditions, any special conditions, applicable to the particular contract.
- xiii. Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that in the ODISHA General Clauses Act.

2. PRICE:

1. The price quoted should be firm, F.O.R. destination inclusive of freight, Insurance, Packing, Forwarding charges inclusive discount if any.
2. Taxes, if any shall be mentioned extra. The Tenderer may quote rate in respect of different make materials as per scheduled.

3. LANGUAGE & MEASURES:

All documents pertaining to the contract including specifications, schedule, notices, correspondence, operating and maintenance instructions or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

4. RIGHT TO REJECT/ ACCEPT ANY TENDER:

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the interest of the OPTCL. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantities of work at the time of placing final work order.

5. COMPLETION OF WORK:

The works awarded should be commenced from 15 days of the award of the contract and to be completed within 60 days after issue of work order.

6. FORCE MAJEURE:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall within Ten (10) days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

7. EXTENSION OF TIME:

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

8. GUARANTEE PERIOD:

i) The work done by the contractor shall be guaranteed for a period of 12 months from the date of completion of work against any bad materials used and bad workmanship done for the work. The above guarantee certificate shall be furnished to the ordering authority for his approval. Any defects noticed during this period shall be rectified by the contractor, free of cost to OPTCL within one month, upon written notice from OPTCL provided such defects are due to bad materials used and bad workmanship failing which provision of clause 13 shall apply.

ii) The work failed or found defective during the guarantee period shall have to be guaranteed after rework for a further period of 12 months from the date of completion of work. The Bank Guarantee is to be extended accordingly without any financial burden to OPTCL.

9. GST REGISTRATION NO., PAN CARD, CIVIL LICENSE & EHT/HT LICENSE:

Scanned copies of PAN, GST Registration, Civil license & EHT/HT License or (JV with Electrical Contractor license (EHT/ HT) valid on the date of opening of tender should be uploaded along with tenders, failing which the tender will be rejected. The contractor or their authorized representatives should produce the original documents for verification within 10 days from the date of opening of tender. Those who fail to produce the same and found not to be valid at the time of verification, their tenders will be rejected.

10. B.G. TOWARDS SECURITY DEPOSIT, 100% PAYMENT AND PERFORMANCE GUARANTEE:

[i] A Composite Bank Guarantee as per the Proforma enclosed at Annexure-III of the specification for 3% [Three percent] of the total contract value shall be furnished from any nationalized/scheduled bank having a place of business at Angul, to the office of General Manager [EHT [O&M] Circle, Chainpal] OPTCL within 15 days from the date of issue of the work order. The BG shall be executed on non judicial stamp paper worth of Rs. **50.00 [Rupees Fifty]** only or as per the prevalent rules, valid for a period 14 months from the last date of stipulated work completion period, for scrutiny and acceptance, failing which the work order will be liable for cancellation without any further written notices. The BG should be accompanied by a confirmation letter from the concerned bank and should have provision for encashment at Angul, before the Bank Guarantee is accepted and all concerned intimated. The B.G should be revalidated as and when intimated to you to cover the entire guarantee period.

OR

The Firm may deposit the same may be furnished in shape of Demand Draft to be drawn in favour of EHT (O&M) Circle Chainpal, Payble at UCO Bank, TTPS Branch. (In case the D.D made from any other nationalized bank payable at any clearing branch at Talcher/Angul will be allowed, But the bidders have to deposit the collection fee (Bank transaction fee) along with the paper cost. 11. Additional Performance Security:- Additional performance security i.e. the differential amount of the bid amount and the estimated cost shall be deposited in shape of Bank Guarantee / Term Deposit Receipt pledged in favour of General Manager, EHT (O&M) Circle, Chainpal (BG in the prescribed format of OPTCL) **within 05 days by the successful bidder** after opening of the tender. The same amount shall be released / refunded after execution of the work without any interest. In this regard latest guidelines of OPTCL / OPWD shall be followed. **The successful Bidder has to submit written application, addressed to undersigned for refund of the Additional Performance Security.**

12. TERMS OF PAYMENT:

- i. **97% of the value of work done shall be paid to contractor subject to completion of work in all respect. Balance 3% shall** be paid on submission of performance Bank guarantee of equivalent amount with validity of two months more than the guarantee period. Performance Bank guarantee shall be released after successful completion of validity period. The Bill payment along with full taxes & duties (if any) shall be made after successful completion of the work in all respect as per JMC and verification thereof subject to approval of guarantee certificate & performance BG. Taxes and duties will be deducted from the bill as per statutory norm.
- ii. In the event of any breach or default in all or any condition of the contract, the contract Security-cum-performance guarantee shall be forfeited.
- iii. No interest shall be payable on contract Security-cum-Performance Guarantee.

13. PRICE REDUCTION FOR DELAY IN COMPLETION OF CONTRACT:

- a. Penalty shall be imposed @**0.5% (half percent)** of contract price for each calendar week of delay of part thereof subject to maximum of @ 5% (five percent) of contract amount. Charges towards penalty shall be counted after scheduled date of completion/issue of clear instruction to the contractor for commencement of works by The General Manager,EHT (O & M) circle, Chainpal /concerned Dy. General Manager, (O&M) Division, Chainpal..
- b. If the Contractor fails to supply the Materials/Equipment or fails to complete the erection including civil works within the due date of agreed key mile stones as defined in the Works Completion Schedule, OPTCL shall have the right to reduce price @0.5% for each week of delay or part thereof limited to maximum of 5% of the cost (exclusive of GST) of the undelivered portion of the materials/equipment and incomplete portion of works.
- c. Equipment/Materials will be deemed to have been supplied only when all its components, parts/accessories and free spares are also delivered, erection including associate civil works will be deemed to be completed when those Equipment/Materials have been successfully erected in all respect as per the Scope of Works.
- d. The total amount of Price Reduction Schedule for delay under the Contract will be subject to a maximum of 5% of Contract Value (exclusive of GST) to be applicable.
- e. OPTCL shall recover the price reduction schedule from the bills of the contractor.
- f. However, if the price reduction schedule remain un-recovered the same shall be recovered from the Contract Performance Bank guarantee.

14. VALIDITY:
